Objective and Investment Policy

Objective

To achieve long-term (in excess of 5 years) total return (the combination of income and growth of capital) by investing in a mix of assets from around the world and aims to limit the average volatility (the amount by which the Fund's value increases or decreases), per annum over rolling 5 year periods to 9%.

There is no guarantee that the objective will be met over any time period and at any time the actual volatility may be higher or lower than 9%. You may get back less than you invest.

Investment Policy

To invest at least 70% of its assets in other Funds which are "passively managed" (i.e. the managers of passive Funds buy and sell investments with the aim of matching the return of, for example, an index).

The Fund can invest in various asset types including; bonds (which are loans that usually pay interest), company shares, property, infrastructure, hedge Funds and cash.

The Fund will have a high exposure to lower risk assets such as bonds and cash.

The Portfolio Manager forecasts the risk and return of the asset types over a number of years to determine the mix of assets to invest in to achieve the Fund's objective. The Portfolio Manager will adjust the mix of assets to reflect changes in their forecasts or to take advantage of investment

opportunities that in their opinion represent good value.

Please note that the objective to limit volatility may restrict the type and amount of assets the Fund holds and therefore limit the potential gains and losses.

The Fund will invest in a focused range of funds (which may include funds managed by the Manager, the Portfolio Manager or their associates).

Other features of the Fund:

The Fund is actively managed. The Portfolio Manager uses its expertise to select investments for the Fund and has the discretion to invest without the need to adhere to a particular benchmark.

You can buy and sell shares in the Fund on each business day.


Any income generated from the Fund is reinvested and reflected in the value of your investment.

Derivatives (whose value is linked to that of another investment, e.g. company shares, currencies) may be used to manage the risk profile of the Fund, reduce costs or generate additional income.

The Fund is risk level 1 in a range of 5 Funds, where 1 is the lowest risk and 5 indicates the highest risk.

Risk and Reward Profile



This indicator shows how much the Fund has risen and fallen in the past, and therefore how much the Fund's returns have varied. It is a measure of the Fund's volatility.

The higher a Fund's past volatility, the higher its position on the scale and the greater the risk that investors may have experienced losses as well as gains.

The Fund has been classed as 4 because its volatility has been measured as average.

This indicator is based on historical data and may not be a reliable indication of the future risk profile of the Fund.

The risk and reward profile shown is not guaranteed to remain the same and may change over time.

The lowest number on the scale does not mean that the Fund is risk-free.

The value and income from the Fund's assets may go down as well as up. This will cause the value of your investment to fall as well as rise.

The Fund targets a risk level of 1 which is a level of risk relative to the 4 other Funds in the range. The Risk and Reward profile scale above is calculated differently. The two measures are not comparable. The lowest number on the scale does not mean that a fund is risk free.

- Currency Risk: As the Fund invests in overseas securities, movements in exchange rates, when not hedged, cause the value of your investments

to increase or decrease. Currency hedging, where applied, may not fully eliminate this risk and mismatches can occur.

- Credit Risk: The value of a bond or other fixed interest security may be affected by its credit rating. A lower credit rating increases the risk that the issuer may not pay interest or repaying the loan. Fixed interest securities are also influenced by trends in interest rates and inflation, which can cause their value to fluctuate.
- Property Securities Risk: The Fund invests in property funds or in the shares of companies that own or manage property (such as real estate investment trusts) rather than in property directly. Property related investments can become illiquid, increasing the risk that positions cannot be sold quickly or at reasonable priced. The value of these investment may also fluctuate more than the value of the property itself, which could negatively impact the value of the Fund.
- Counterparty Risk: The failure of a firm involved in a transaction with the Fund or providing services to the Fund may expose the Fund to financial loss.
- Derivative Risk: The Fund may use derivatives, which can be complex instruments. A derivative may not perform as expected and can create losses greater than its initial cost. A relatively small movement in value of the underlying investment may have a much larger impact, positive or negative, on the value of the Fund than if the Fund held the underlying investment directly.
- Change in Interest Rate Risk: A rise in interest rates generally causes bond prices to fall. The value of fixed interest securities may also be affected by trends in interest rates, inflation and credit ratings.


The ongoing charges figure is based on expenses as at 30 April 2025. This figure may vary from year to year.

The ongoing charges are taken mainly from the income of the Fund. They exclude portfolio transaction costs, except in the case of an entry/exit charge paid by the Fund when buying or selling units in another collective investment undertaking.

A dilution adjustment (an adjustment to cover the dealing costs incurred by the Fund) may be applied when you buy or sell shares. This changes the price you pay or receive and is normally only applied when dealing costs are significant.
