# Small Estates Declaration

#### How to fill in this form

This form should only be completed if a Grant of Probate or Letters of Administration are not being applied for, and the deceased's investment portfolio with us is not more than £30,000.

The Small Estates Declaration must be signed by the next of kin. The next of kin must be related to the deceased by marriage or blood. The intestacy rules govern the order of priority in which relatives of the deceased are entitled to the deceased's estate, as follows:

- · Husband, wife or civil partner of the deceased.
- · Son or daughter of the deceased (including stepchildren if formally adopted).
- Parents of the deceased.
- Brothers or sisters of the deceased.

#### WHAT YOU NEED TO DO

Submit the original form (we cannot accept photocopies) with:

- · Original or certified copies of the investor's Will and Death Certificate.
- Bereavement Claim Form signed by all Executors/Administrators (if you want to sell the investment).
